# For Iron Workers District Council of Southern Ohio & Vicinity Benefit Trust

This is a summary of the annual report of the Iron Workers District Council of Southern Ohio & Vicinity Benefit Trust, EIN 31-0557391, Plan No. 501, for period February 01, 2018 through January 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has contracts with Humana Insurance Company, Humana Insurance Company Of New York, Metropolitan Life Insurance Company, and The Union Labor Life Insurance Company to pay health, life insurance, stop loss, and ADD claims incurred under the terms of the plan. The total premiums paid for the plan year ending January 31, 2019 were \$7,164,530.

# **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$31,222,035 as of January 31, 2019, compared to \$30,626,734 as of February 01, 2018. During the plan year the plan experienced an increase in its net assets of \$595,301. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$56,687,679, including employer contributions of \$46,385,580, participant contributions of \$10,214,013, and earnings from investments of \$88,086.

Plan expenses were \$56,092,378. These expenses included \$4,061,964 in administrative expenses, and \$52,030,414 in benefits paid to participants and beneficiaries.
