

SUMMARY ANNUAL REPORT

For Iron Workers District Council of Southern Ohio & Vicinity Annuity Trust

This is a summary of the annual report for Iron Workers District Council of Southern Ohio & Vicinity Annuity Trust, EIN 31-6108920, Plan No.001, for period February 01, 2018 through January 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$23,719,357. These expenses included \$711,567 in administrative expenses, and \$23,007,790 in benefits paid to participants and beneficiaries. A total of 9,589 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$373,342,641 as of January 31, 2019, compared to \$370,797,581 as of February 01, 2018. During the plan year the plan experienced an increase in its net assets of \$2,545,060. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$26,264,417, including employer contributions of \$22,792,134, earnings from investments of (\$1,853,286), and earnings from a guaranteed investment contract of \$5,325,569.

The plan has a contract with Massachusetts Mutual Life Insurance Company. The total premiums paid for the plan year ending January 31, 2019 were \$-0-.

Minimum Funding Standards

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
