

**SUMMARY ANNUAL REPORT FOR  
IRON WORKERS DISTRICT COUNCIL OF SO OH & VICINITY ANNUITY TRUST**

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan of Iron Workers District Council of So Oh & Vicinity Annuity Trust and Employer Identification Number 31-6108920/Plan Number 001 for the plan year 02/01/2023 through 01/31/2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a multiemployer, defined contribution plan with the following characteristics: money purchase, ERISA section 404(c), total participant-directed account, total or partial participant-directed account, member of a controlled group.

**Basic Financial Statement**

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$28,348,461. These expenses included \$1,196,131 in administrative expenses and \$27,152,330 in benefits paid to participants and beneficiaries, \$0 in certain deemed and/or corrective distributions, and \$0 in other expenses. A total of 7958 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$475,706,945 as of the end of the plan year, compared to \$440,911,679 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$34,795,266. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$63,143,727, including employer contributions of \$33,766,759, employee contributions of \$0, other contributions/other income of \$211,740, and earnings from investments of \$29,165,228.

**Minimum Funding Standards**

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
