Date of Notification: May 2025

Please note the following Plan changes will take effect for hours worked on and after January 1, 2025, unless otherwise stated:

Accrual Rate Increase

Effective for hours worked on and after January 1, 2025, the accrual rate under the Plan has increased from \$120.00 to \$140.00.

Hour Bank hours earned on and after January 1, 2025 will be valued at the new accrual rate of \$140.00, while Hour Bank earned prior to January 1, 2025 will remain at the prior accrual rate value.

Special Benefit Credit

If you work at least 2,000 hours in a calendar year *within this District Council* on and after January 1, 2025, you will receive a Special Benefit Credit of \$20.00.

Any such Special Benefit Credits are added to the Pension for that year only, beginning with the 2025 calendar year.

For this purpose, in determining if the 2,000 hours threshold has been met, any Hours of Service credited as Military Service under the Plan shall be included. However, hours credited for disability or workers' compensation shall be excluded. **Only hours worked within this District Council** will be considered, so additional hours paid due to overtime, reciprocated in from Local Unions outside the Iron Workers District Council of Southern Ohio and Vicinity, or other similar reasons will not be considered for the Special Benefit Credit.

Reserve Hour Bank hours do not apply, and are **not** eligible for the Special Benefit Credit.

Small Benefit Cashouts

Effective for lump-sum distributions on and after February 1, 2025, if the Actuarial Present Value of a benefit payable under the Plan at the time of distribution is less than \$7,000, the Trustees may pay it as a single sum.

Correction in Summary Plan Description amended effective January 1, 2023, as follows:

Pensioners who are eligible to return to work in Covered Employment who are age 62 or older may return to work up to 900 Hours in a year (i.e., up to 75 Hours in a month) without suspending their benefit.
